PRIVACY POLICY

1. Use of your personal data

2. Types of data collected

diagnostic data.

 Device data includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.

3. Disclosure of personal data

We will disclose your personal data with the following parties:

- Service providers that operate at our direction and on our behalf to perform services we outsource to them.
- Authorities, if compelled to do so by a subpoena, court order, or similar legal procedure.
- Other third parties, for example we disclose personal data to advertising platforms at your direction, or security service providers to help prevent unauthorized access to our App.

4. Retention of personal data

We will retain your personal data only as long as necessary to provide you with the App or Service you request, our essential business purposes, such as maintaining the performance of the App, complying with our legal obligations and resolving disputes. When we have no justifiable business need to process your personal data, we will either delete or anonymize it.

5. Security of personal data

We follow strict security procedures in the storage and disclosure of personal data which you have given us to prevent loss, misuse, unauthorized access, disclosure or modification of personal data.

6. Children

We are strongly committed to preserving online privacy for all of our users, including children. Our policy is not to collect any personal data about children under 13 years old. Our Service are offered to users who are the age of 13 years and above. Minors under 13 years of age may have the personal data

that they provide to us through the App deleted by sending an email requesting deletion to the email address set forth in this Policy.

7. Your data protection rights

- You can request access, correction, updates or deletion of your personal data.
- You can object to our processing of your personal data, ask us to restrict processing of your personal data or request portability of your personal data.
- If we have collected and processed your personal data with your consent, then you can withdraw your consent at any time.
